## Independence Day Celebrated with full Gaity at Corporate Office

The 72<sup>nd</sup> Independence Day was celebrated at Corporate Office with full fervor and gaiety. The tricolor was unfurled by Sh. D.S. Thakur, Director (Civil), HPPCL.

Addressing the gathering he said that Chanju-III HEP (48 MW) and Deothal-Chanju HEP (30 MW) are ready for implementation. AFD has also agreed in principle, for funding of these Projects. The bidding documents of Chanju-III (48 MW) and Deothal Chanju HEP (30 MW) will be submitted to French Development Agency, AFD by October, 2018.

Sh. D.S. Thakur elaborated that in case of Sawra Kuddu; Power House, E&M and Barrage works have been completed. Head Race Tunnel excavation works have also been completed on 04.09.2017 and overt lining works are in progress. The progress of Shongtong- Karchham HEP was hampered due to strike by worker union but now the works have been started. HPPCL has implemented SAP across all units, becoming the first state owned public sector utility in the country to implement SAP successfully.

### MoU Signed between HPPCL and IPH Department

The Memorandum of Understanding (MoU) has been signed on 07.08.2018 between Himachal Pradesh Power Corporation Ltd. (HPPCL) and Irrigation & Public Health Department (I&PH), Government of Himachal Pradesh at HPPCL Corporate Office, Shimla for implementation of Grid Connected Canal Top Solar PV Power Plant on the canals owned by I&PH Department that would generate clean energy by efficient utilization of land and conservation of water.

### Public Hearing of Social Impact Assessment Study held for Thana Plaun HEP

The Public hearing for the Thana Plaun Hydro Electric Project (191 was held MW) at Gram Panchayat Kot, Gram Panchayat Tarnoh, Community House Nohli, Gram Panchayat Drubbal and Gram Panchayat on dated 24.08.2018. 25.08.2018 and 27.08.2018. The total 22 Nos. of panchayats are coming under submergence zone of project, out of which the Social Impact Assessment study has been carried 12 Nos out in of Panchayats. The private land to be acquired falls under twelve panchayats.

The area falling under submergence is vast and scattered public hearing was conducted in different five places. Thana Plaun HEP (191 MW) is storage-cum- run of river scheme on right bank of Beas river in Mandi district with dam structure at village Thana downstream of confluence of Rana Khad and river Beas. The Entire water conductor system and underground Power House will be built on right bank of river Beas near village Thana of Gram Panchayat Drubbal in tehsil Jogindernagar in district Mandi. The Government of Himachal Pradesh vide its letter No MPP(F) 2-/2008, Dated 22-9-2009 has allotted this project to Himachal Pradesh Power Corporation Limited for execution in State sector.

The submergence upstream of main dam structure of Thana Plaun HEP (191 MW) along river Beas with the proposed Full Reservoir Level (FRL) will extend up to Bijani near Mandi and along Rana Khad in a length of 4.5 km in Jogindernagar Tehsiland in Arnodi Khad towards Kotli in small length. Along other tributaries of river Beas upstream of Kunkatar up to Bijani extension of reservoir will be in small length.

## सावड़ा कुडडु जल विद्युत परियोजना द्वारा एक दिवसीय भाषण प्रतियोगिता का आयोजन

हिमाचल प्रदेश पावर कारपोरेशन लिमिटेड की सावड़ा कुडडु जल विद्युत परियोजना द्वारा के लिए वितीय वर्ष 2018.19 के लिए स्वीकृत पहली स्कूल प्रतियोगिता 29 सितम्बर 2018 को आयोजित की गई। इस प्रतियोगिता में परियोजना प्रभावित परिवारों के बच्चों के लिए निवारण विषय पर एक भाषण नशा प्रतियोगिता का आयोजन स्कूल स्तर पर किया गया। इस प्रतियोगिता के आयोजन का मुख्य उद्वेश्य सावड़ा कुडडु जल विद्युत परियोजना से प्रत्यक्ष और अप्रत्यक्ष रुप से प्रभावित गांव वासियों के बच्चों को नशे की लत से बचने के लिए जागुरूक करना था। एक दिवसीय भाषण स्कूल प्रतियोगिता में परियोजना से प्रभावित 6 स्कूलों के 24 विद्यार्थियों ने भाग लिया।

इस भाषण प्रतियोगिता में स्कूली बच्चों को कनिष्ठ एवं वरिष्ठ दो भागों में बांटा गया। प्रत्येक वर्ग में प्रथम, द्वितीय एवं तृतीय स्थान के लिए विद्यार्थियों का चयन किया। परियोजना से प्रभावित 6 स्कूलो के 24 विद्यार्थियों ने नशा निवारण पर अपने विचार रखे। 24 विद्यार्थियों में से 14 विद्यार्थी कनिष्ठ वर्ग के एवम 9 विद्यार्थी वरिष्ठ वर्ग के थे, 1 विद्यार्थी विकलांग वर्ग से उपस्थित था। इस प्रतियोगिता के कनिष्ठ वर्ग में राजकीय वरिष्ठ माध्यमिक पाठशाला सनसोग की शीतल ने प्रथम स्थान, राजकीय वरिष्ठ माध्यमिक पाठशाला कुडडु की सिमरन ने द्वितीय और राजकीय वरिष्ठ माध्यमिक पाठशाला संन्सोग की तमन्ना ने तृतीय स्थान प्राप्त किया। वरिष्ठ वर्ग में राजकीय वरिष्ठ माध्यमिक पाठशाला संन्सोग की सोनिया ने प्रथम, शालिनी ने द्वितीय और भारती ने तृतीय स्थान प्राप्त किया।
